Instructions

- Select the relevant option, Contribution or Deposit From Asset. Use one form per account.
- All deposits must be in the name of your IRA: **IRAR Trust FBO (Your Name, Account #)**
- If you are depositing funds via wire or ACH, you must initiate the transaction with your bank. Your bank will not allow us to initiate a wire or ACH on your behalf. We need the information from your bank to allocate the funds to your account once the funds are received.
- Funds sent via check may be subject to a 5 day hold. Wire deposits are available the next business day.
- Use the section "Reference/Special Instructions" in section 2 to send us additional information regarding your deposit. For example: if the funds are to be allocated to multiple assets, please provide the breakdown.

IMPORTANT

Your deposit will be made once we have received the funds and the deposit coupon information to allocate funds.

You must have enough funds in your account to cover any transaction fees applicable. Lack of funds will delay your deposit.

1. ACCOUNT OWNER INFORMATION

Form section for account owner information including fields for Full Name, Account Number, Account Type, Email Address, and Daytime Phone Number.

2. DEPOSIT INFORMATION

2.1 Reason For Deposit (check one of two options and complete the appropriate section)

Form section for Reason For Deposit with sub-sections for Contribution and Income From Asset, including fields for Total Amount, Tax Year, Asset Name, Interest Amount, and Principal Amount.

2.2 Deposit Method (this is how the funds will arrive at IRAR, check one option and complete the appropriate section)

Form section for Deposit Method with options for Check, Wire, and ACH, and a field for Reference/Special Instructions.

2.3 Deposit Frequency

Form section for Deposit Frequency with radio button options for One-Time, Monthly, Quarterly, Annually, and Other.

3. PAYMENT OF IRAR FEES
