Use this form when transferring funds and/or assets from an IRA at another Custodian directly to your IRA with IRAR.

## Fees and Processing

Transfer processing fee: \$0

If transfer is by wire: \$30

If overnight delivery is requested: \$30

IRAR processing time: Same day

To expedite your transfer, contact your current custodian to process your request. Their processing can be from 3-14 days.

### **Instructions**

- ☐ If you are transferring non-cash assets, you must submit a copy of a current statement (dated within 6 months) for the account you are transferring.
- □ Contact your current Custodian to inquire if a Medallion Signature Guarantee is required. If required, one should be obtained from an authorized member of the Securities Transfer Agents Medallion Program (STAMP). Check with your local bank or broker/dealer to see if they offer this service.
   A Notary Public is not acceptable.
- ☐ Contact your current Custodian to inquire if they accept fax copies of your transfer request. This can speed up transactions.
- If you are transferring an annuity, you may incur surrender/penalty charges.
   Please attach the original policy or a statement.
- ☐ If you are transferring a Brokerage IRA and wish to transfer as cash, you will need to liquidate the appropriate assets prior to completing and submitting the Account Transfer Form.

#### **IMPORTANT**

When transferring funds to make an investment, transfer an amount that will cover the purchase of the investment and transaction fees. Lack of funds will delay your investment purchase.

For each account that is being transferred to IRAR, you **MUST** fill out a separate form.
